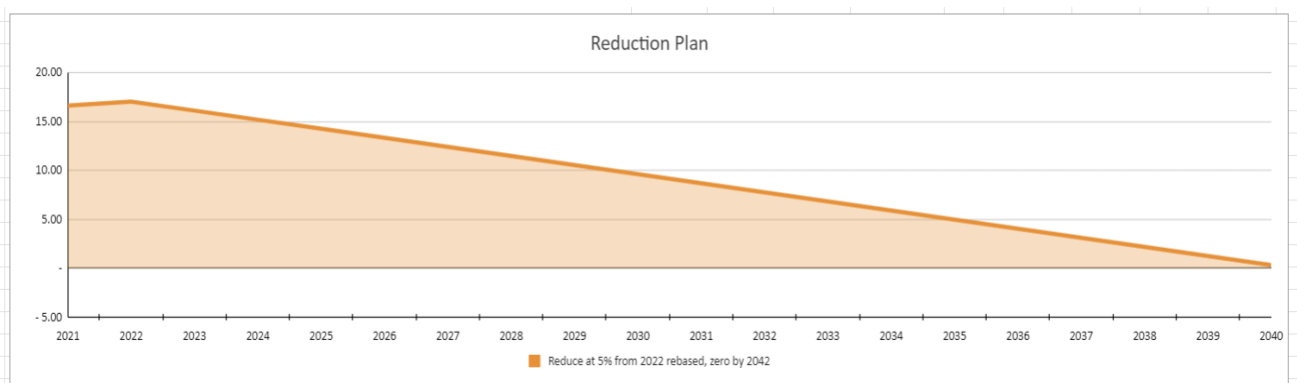

## Emissions Reduction Targets

In order to continue our progress to achieve Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 13.63 tCO<sub>2</sub>e by 2027. This is a reduction of 23%.

## Carbon Reduction Projects

### Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2021 baseline and the measures will be in effect when performing the contract.

Current and completed carbon reduction projects:

- We became a signatory of the Climate Pledge to join 400 other widely-recognised global players in a commitment to become net-zero carbon by 2040, 10 years ahead of the Paris Agreement.
- We have embraced a 100% hybrid model of working, encouraging our people to be present on client sites as required of the business but working from home when possible.
- Since the launch of our Cycle to Work Scheme we have further supported our London-based staff to cycle to work by providing free, private and secure bicycle storage within walking distance of the office.
- We have increased our Employee Benefits to include an Electric Vehicle leasing scheme.
- We have developed an in-house cloud cost optimisation tool that will be used to measure our cloud computing usage, improve infrastructure efficiencies and reduce our carbon footprint.
- We have launched a regular sustainability feature in our monthly newsletter with seasonal themes to promote the use of renewables and a greener lifestyle.

In the future we hope to implement further measures such as:

- Fine-tuning our cloud optimisation tool for continuous monitoring of our cloud-based estate to ensure we are on target to meet our Climate Pledge and carbon reduction targets.
- Providing an environmental impact assessment service to our clients and supply chain to assist them in understanding their carbon emissions and identifying ways to reduce them.
- Empowering our people to embrace renewables by adding to our Employee Benefits package schemes such as collective wind-farm or solar park ownership.
- Enabling our people to become more 'green smart' by incorporating sustainability themes into our employee social events.
- Ensuring that net-zero is a key ambition across our business and up and down our supply chain, (including our partners and any future mergers and acquisitions)

## Declaration and Sign Off
